

IT'S EASY TO GIFT A MEMBERSHIP


The new “gift a membership” feature allows a member or a visitor to purchase a membership as a gift for a family member, friend, or co-worker.

It is **important** for accurate recordkeeping that members use this form to give a gift membership rather than using the JOIN form.

Select “[Gift a Membership](#)” from the “**Join Us**” drop down menu.

Then, just click on the **Gift a Membership** button to open the Gift Membership contribution form. Please note that the woman receiving the gift is the **Member** on this form and the person making the gift is the **Donor**.

Step 1: Select the membership amount; \$275 is the recommended minimum.
